

SUMMARY OF PERMITTING AGENCIES—MARQUETTE COUNTY

1. **Township**—building permit/zoning/setbacks (Marquette & Chocolay Townships have individual grading ordinances)
2. **City of Marquette/Negaunee/Ishpeming**—building permit /zoning/setbacks
3. **Marquette County Conservation District**—soil erosion permit for projects that are greater than one acre disturbed and/or within 500’ of lake/stream
4. **County of Marquette**—building permit
5. **Marquette County Health Department**—septic and well permit
6. **Michigan Department of Transportation**—ROW permit, if applicable
7. **Marquette County Road Commission**—ROW permit, if applicable
8. **Marquette County Drain Commissioner**—Permit for work in Badger Creek/Badger Creek Drain
9. **Michigan Department of Environmental Quality**—permit for work in stream, lake, along lakeshore, wetlands, floodplain.
10. **Federal Army Corps of Engineers**—permit for work in waters/wetlands of the United States [under COE jurisdiction] involving dredging or filling
